Your Directors are pleased to present the Fifteenth Annual Report of your Company together with the Audited Statement of Accounts and the Auditors' Report for the financial year ended, March 31, 2023.

2. State of Affairs

The words of the historian, Adam Zamoyski written in the preface to his book - Poland, A History -"There is a great difference between writing up a bankrupt business and writing up one that has been through hard times and turned the corner" cannot ring truer for our Company. During this year we have achieved three milestones, the third being the outcome of the first two. A. Repaying all debt, thereby becoming Zero Debt Company - which has eliminated any lender overhang on the Company. B. Generating Monthly Surplus C. Re-starting Own Book Disbursement. Will re-iterate what has been stated last year, we have been able to "turn the corner" because of a. continued support of most of our colleagues and their continued commitment to see through the tough days and continue to contribute through consistent and persistent follow-ups, in addition to our marginally increased ability to attract new talent; b. increased use of legal tools c. ability to generate collections by restarting and consolidating on collections of hitherto unattended areas & abandoned portfolio - this has been the third year in succession where we have increased such areas under our coverage as well as have been witnessing collections traction from such areas. The Company continues to build upon both the ongoing partnerships and we presently have a very high likelihood of initiating two more partnerships. There has been a further increase in geographical areas under the on-going partnerships. The company has lent on its own book, thereby finally being able to aid the collections in bringing down the NPA Percentages and in a few cases, even the NPA Numbers, as fresh disbursements amongst various other positive outcomes - also, send out the message that our Company is Alive and Kicking. While the Company continues to disburse in one form or another (either own-book or through partnerships) in 4 out of the 6 states that the Company operates in, it is very likely that the Company will soon start lending in the 5th State - Odisha. The aim will be to keep building on these positives and maintain focus on the following - a. keep collecting the NPAs/write-offs b. keep building on partnerships and look for new ones wherever possible c. keep on disbursing with an aim to create a healthy book d. seek to raise debt towards leveraging the company and deploy such borrowing/s to further create a healthy book, so that we finally start taking quick strides towards the elusive milestone – that of becoming profitable.

3. Review of Business Operations

During the year under review, the Company has earned Rs.601.62 lakhs as Revenue from Operations and Rs.494.27 lakhs from Other Income. The Profit/(Loss) before tax for the year has been Rs. (243.86) lakhs as against Rs. 954.26 lakhs during the previous financial year.

The Company is debt-free as on March 31, 2023. Thereby, Current Maturities as on March 31, 2023 are NIL as against Rs. 827.02 lakhs in the previous year.

4. Share Capital

During the year under review, there is no change in Authorised Share Capital and Paid-up Share Capital of the company.

5. Dividend

Your Directors do not recommend for any dividend for the year ended March 31, 2023.

6. Transfer of amount(s) to Reserve (s)

As per Section 29C (1) of National Housing Bank Act, 1987 the Company is required to transfer atleast 20% of its net profit every year to a reserve before a dividend is declared. During the year no amount is required to be transferred to the Special Reserve.

For transfer to reserves in terms of section 134(3)(J) of the Companies Act, 2013, for the financial year ended March 31, 2023 your Directors propose to transfer Nil amount to General Reserve of the company and the amount of Rs. (2,43,86,474) will be transferred to Profit & Loss account.

7. Deposit

Your Company is registered as a non-deposit taking Housing Finance Company with National Housing Bank and hence does not accept any deposits. No deposits were accepted from the public in the financial year ended March 31, 2023.

8. Particulars of Loans, Guarantees or Investments by Company

The Company has not granted any loans or provided any guarantees attracting the provisions of Section 186 of Companies Act, 2013.

The Company has not made any Investment during the financial year 2022-23. Therefore, no need to comply with the provisions of Section 186 of the Company Act, 2013.

(FRN 104744W) were appointed as the Statutory Auditors of the Company for a period of five years starting from financial year 2022-23 and that they shall hold office from the conclusion of 14th Annual General Meeting till the conclusion of the 19th Annual General Meeting to be held in the year 2027 i.e for financial year 2026-27 as per the Guidelines of Reserve Bank of India for Appointment of Statutory Central Auditors (SCAs)/Statutory Auditors (SAs) of Commercial Banks (excluding RRBs), UCBs and NBFC s (including HFCs).

18. Auditors' Report

The observations of the Statutory Auditors, when read together with the relevant notes to the accounts and accounting policies are self-explanatory and do not call for any further comment.

19. Risk Management Policy & Internal Control Adequacy

The Company has in place the mechanism to assess, monitor & mitigate various risks to key business objectives. Major risks identified by the business and functions are systematically addressed through mitigating actions on a continuing basis. These are discussed at the meetings of the Risk Management

Committee and Board of Directors of the Company.

The Company's internal control systems are commensurate with the nature of its business and the size and complexity of its operations. Significant audit observations and follow-up actions thereon are reported to the Board. The Board of Directors reviews the adequacy and effectiveness of the Company's internal control environment and monitors the implementation of audit recommendations.

20. Related party transactions

During the year under review, the Company has not entered into any related party transaction. Therefore, the provisions of Section 188 of the Companies Act, 2013 were not attracted. Thus, disclosure in AOC-2 is not required.

21. Conservation of Energy, Technology Absorption and Foreign Exchange Earnings and Outgo

The Company has continued developing its in-house software METIS in order to create a comprehensive technology-driven workflow across the organization. All loan processes move through the system and each loan file is traceable in real time with its current stage along with its movement timelines. The Company keeps upgrading METIS in line with the business requirements and some of the major implementations completed during the financial year 22-23 are given below -

- 1. End-to-end integration of loans disbursed with one of its Partners right from Sourcing to Disbursement including data exchange with the Partner.
- Ease in calculation w.r.t. to Travel Claims of the field staff by way of an automated record of travel meter readings.
- Development of new modules/features like Courier Module, Stationary Module, a feature to update the borrowers' residential address by geo-tagging of the location, and such additional features in METIS to automate the operations wherever possible.
- 4. Migration of METIS and the Company's website from HTTP to HTTPS for providing high security.
- 5. Further, the HR Module is being continuously evolved to automate various HR functions like information about the Induction Schedule, OTP-based download of Salary Slip, Generation of Attendance Reports, Creation of Employee Profile, Automation of various HR documentation like confirmation letter, appointment letter, appraisal letter, loan letter and experience letter etc.

The Company has Employee Stock Option Plan for its Employees/ Directors. The Company has granted options under the Stock Option Scheme to Mr. Prashant Banerjee, Chief Executive Officer, under his Employment Agreement and other 8 (Eight) employees who have completed 7 years of service with the Company as of January 01, 2022. However, there has not been any vesting under the Stock Option Scheme during the year under review.

26. Sexual Harassment Policy

Report on the Audit of the Financial Statements

Opinion

We have audited the accompanying financial statements of Swarna Pragati Housing Microfinance Private Limited (the "Company"), which comprise the Balance Sheet as at March 31, 2023, the Statement of Profit and Loss and the Cash Flow Statement for the year then ended, and notes to the financial statements, including a summary of significant accounting policies and other explanatory information (hereinafter referred to as 'financial statements').

In our opinion and to the best of our information and according to the explanations given to us, the aforesaid financial statements give the information required by the Companies Act, 2013 (the "Act"), in the manner so required, and give a true and fair view in conformity with the Accounting Standards prescribed under section 133 of the Act read with the Companies (Accounting Standards) Rules, 2006, as amended ("I-GAAP") and other accounting principles generally accepted in India, of the state of affairs of the Company as at March 31, 2023, its loss and its cash flows for the year ended on that date.

Basis for Opinion

Corporate Information

Swarna Pragati Housing Microfinance Private Limited (the Company) was incorporated in India on January 05, 2009 to provide housing finance in respect of new house / habitat and upgradation and repairs/ renovations of existing shelters by way of productive housing in Indian rural areas. The Company is registered as a housing finance company without accepting public deposits with National Hosuing Bank ('NHB') with effect from August 31, 2009 having registration no. 08,0075.09

2 Basis of preparation of financial statements

The financial statements have been prepared in confirmity with generally accepted accounting principles in India (Indian GAAP') to comply in all material respects with the Accounting Standards (AS') notified under section 133 of the Companies Act, 2013 (the 'Act') read together with Rule 7 of the Companies (Accounts) Rules, 2014 and the Companies (Accounting Standards) Amendment Rules, 2016, The National Housing Bank Act, 1987 and Housing Finance Companies (NHB) Directions, 2010 (as amended) ('the NHB Directions') issued by NHB from time to time. The financial statements have been prepared on an accrual basis and under the historical cost convention except as detailed in note no. 2.1(h). The accounting policies have been consistently applied by the province user applied by the Company and are consistent with those used in the previous year.

Summary of significant accounting policies 2.1

Current/ Non Current classification of assets and liabilities (a)

As required by Schedule III, the Company has classified assets and liabilities into current and non-current based on the operating cycle. An operating cycle is the time between the acquisition of assets for processing and their realisation in cash or cash equivalents. Since normal operating cycle is not readily determinable considering the Company's business i.e housing finance, the operating cycle has been considered as 12 months.

Use of estimates (b)

The preparation of financial statements in conformity with Indian GAAP requires the management to make judgments, estimates and assumptions that affect the reported amounts of revenues, expenses, assets and liabilities and the disclosure of contingent liabilities, at the end of the reporting perior general disclosure and additional and the disclosure of contingent liabilities, at the end of the reporting perior general disclosure and actions, uncertainty about these assumptions and estimates could result in the outcomes requiring a material adjustment to the carrying amounts of assets or liabilities in future penods.

Property, plant and equipment (c)

Property, plant and equipment are stated at cost, net of accumulated depreciation and accumulated impairment losses, if any. The cost comprises purchase price, borrowing costs if capitalization criteria are met and directly attributable cost of bringing the asset to its working condition for the intended use. Any trade discounts and rebates are deducted in arriving at the purchase price

Subsequent expenditure related to an item of fixed asset is added to its book value only if it increases the future benefits from the existing asset beyond its previously assessed standard of performance. All other expenses on existing fixed assets, including day-to-day repair and maintenance expenditure and cost of replacing parts, are charged to the statement of profit and loss for the period during which such expenses are incurred.

Gains or losses arising from derecognition of fixed assets are measured as the difference between the net disposal proceeds and the carrying amount of the asset and are recognized in the statement of profit and loss when the asset is derecognized.

Intangible assets (d)

Intangible assets acquired separately are measured on initial recognition at cost. The cost of intangible assets acquired in an amalgamation in the nature of purchase is their fair value as at the intrangular associated acquired acquired acquired acquired account inter recognition of a cost less accumulated amortization and accumulated impairment losses, if any. Internally generated intangible date of amalgamation, Following initial recognition, intangible assets are carried at cost less accumulated amortization and accumulated impairment losses, if any. Internally generated intangible assets, excluding capitalized development costs, are not capitalized and expenditure is reflected in the statement of profit and loss in the year in which the expenditure is incurred.

Intangible assets are amortized on a written down value basis over the estimated useful economic life. The Company uses a rebuttable presumption that the useful life of an intangible asset will not exceed the years from the date when the assets is available for use. If the persuasive evidence exists to the affect that useful life of an intangible asset exceeds ten years, the Company amortizes the intangible asset over the best estimate of its useful life. Such intangible assets and intangible assets not yet available for use are tested for impairment annually, either individually or at the cash-generating unit level. All other intangible assets are assessed for impairment whenever there is an indication that the intangible asset may be impaired.

The amortization period and the amortization method are reviewed at least at each financial year end. If the expected useful life of the asset is significantly different from previous estimates, the amonucation period and the anonucation menod are reviewed at least at each mancing year end, in the expected declining on the asset is significantly different room previous estimates, the amonucation period is changed accordingly. If there has been a significant change in the expected pattern of economic benefits from the asset, the amonucation method is changed to reflect the changed pattern. Such changes are accounted for in accordance with AS-5 Net Profit or Loss for the Period, Prior Period Items and Changes in Accounting Policies.

Gains or losses arising from derecognition of an intangible asset are measured as the difference between the net disposal proceeds and the carrying amount of the asset and are recognized in the statement of profit and loss when the asset is derecognized.

Depreciation on Property, plant and equipment/ Amortisation of Intangible asset Depreciable amount for assets is the cost of an asset, or other amount substituted for cost, less its estimated residual value.

Depreciation on property, plant and equipment has been provided on the written down value method as per the useful life prescribed in Schedule II to the Companies Act, 2013.

Loans to borrowers (f)

Loans are stated at the amount advanced, as reduced by the amounts received up to the balance sheet date.

(g) Investments

Investments, which are readily realisable and intended to be held for not more than one year from the date on which such investments are made, are classified as current investments. All other investments are classified as long-term investments. Current investment are carried in the financial statements at lower of cost and fair value except for investment in mutual funds which are carried at their Net asset value declared by the mutual fund in accordance with the NHB Directions.

(h) Revenue recognition

Revenue is recognized to the extent that it is probable that the economic benefits will flow to the Company and the revenue can be reliably measured.

(a) Interest income

terest income on loans is recognised by applying interest rate implicit in the contract. In case of non-performing assets, interest income is recognised on receipt basis in accordance with the NHB directions.

(c) Processing fee income

rocessing fee income on loan is recognised as income in the year in which the loan is disbursed to the borrowers.

(d) Profit/ Loss on sale of investments

Profit/loss earned on sale of investments is recognised on trade date basis. Profit or loss on sale of investments is determined on the basis of the weighted average cost method. On disposal of an investment, the difference between its carrying amount and net disposal proceeds is charged or credited to the statement of profit and loss.

(i) Retirement and other employee benefits

Defined contribution plans

Deniced contribution plans in the provisions of the Employees Provident Funds and Miscellaneous Provisions Act, 1952, eligible employees of the Company are entitled to receive benefits with respect to provident fund, a defined contribution plan in which both the Company and the employee contribute monthly at a determined rate (currently 12% of employee's basic salary). Company's contribution to Provident Fund is charged as an expense in the Statement of Profit and Loss.

eave benefits

Compensated absences with respect to leave encashment benefits payable to employees of the Company while in service, on retirement, death while in service or on termination of employment with respect to accumulated leaves outstanding at the year end are accounted for on the basis of an actuarial valuation as at the balance sheet date.

Defined benefit plans

Benefits payable to eligible employees of the Company with respect to gratuity, a defined benefit plan is accounted for on the basis of an actuarial valuation as at the balance sheet date. In accordance with the Payment of Gratuity Act, 1972, the plan provides for lump sum payments to vested employees on retirement, death while in service or on termination of employment in an amount equivalent to 15 days basic salary for each completed year of service. Vesting occurs upon completion of five years of service. The present value of such obligation is determined by the projected unit credit method and adjusted for past service cost and fair value of plan assets as at the balance sheet date through which the obligations are to be settled. The resultant actuarial gain or loss on change in present value of the defined benefit obligation or change in return of the plan assets is recognised as an income or expense in the Statement of Profit and Loss. The expected return on plan assets is based on the assumed rate of return of such assets.

(i) Leases

Operating Lease

Where the Company is lessee

Leases where the lessor effectively retains substantially all the risks and benefits of ownership of the leased asset are classified as operating leases. Operating lease payments are recognized as an expense in the statement of profit and loss on a straight line basis over the tenure of the lease

(k) Taxes on income

Tax expense comprises current and deferred tax. Current income-tax is measured at the amount expected to be paid to the tax authorities in accordance with the Income-tax Act. 1961 enacted In India and tax laws prevailing in the respective tax jurisdictions where the Company operates. The tax rates and tax laws used to compute the amount are those that are enacted or substantively enacted, at the reporting date. Current income tax relating to items recognized directly in equity is recognized in equity and not in the statement of profit and loss. Deferred income taxes reflect the impact of timing differences between taxable income and accounting income originating during the current year and reversal of timing differences for the earlier years. Deferred tax is measured using the tax rates and the tax laws enacted or substantively enacted at the reporting date. Deferred income tax relating to items recognized directly in equity is recognized in equity and not in the statement of profit and loss. recognized in equity and not in the statement of profit and loss.

Deferred tax liabilities are recognized for all taxable timing differences. Deferred tax assets are recognized for deductible timing differences only to the extent that there is reasonable certainty that sufficient future taxable income will be available against which such deferred tax assets can be realized. In situations where the Company has unabsorbed depreciation or carry forward tax losses, all deferred tax assets are recognized only if there is virtual certainty supported by convincing evidence that they can be realized against future taxable profits.

The carrying amount of deferred tax assets are reviewed at each reporting date. The Company writes-down the carrying amount of deferred tax asset to the extent that it is no longer reasonably certain or virtually certain, as the case may be, that sufficient future taxable income will be available against which deferred tax asset can be realized. Any such write-down is reversed to the extent that it becomes reasonably certain or virtually certain, as the case may be, that sufficient future taxable income will be available

Minimum alternate tax (MAT) paid in a year is charged to the statement of profit and loss as current tax. The Company recognizes MAT credit available as an asset only to the extent that there is convincing evidence that the Company will pay normal income tax during the specified period, i.e., the period for which MAT credit is allowed to be carried forward. In the year in which the Company recognizes MAT credit as an asset in accordance with the Guidance Note on Accounting for Credit Available in respect of Minimum Alternative Tax under the Income-tax Act, 1961, the said asset is created by way of credit to the statement of profit and loss and shown as "MAT Credit Entitlement," The Company reviews the "MAT credit entitlement" asset at each reporting date and writes down the asset to the extent the Company does not have convincing evidence that it will pay normal tax during the specified pariod.

Earnings per Share (1)

Basic earnings per share are calculated by dividing the net profit or loss for the year attributable to equity shareholders by the weighted average number of equity shares outstanding during the

Diluted earnings per share are calculated by dividing the net profit or loss for the year attributable to equity shareholders as adjusted for dividend, interest and other charges to expense or income relating to the dilutive potential equity shares, by the weighted average number of shares outstanding during the year as adjusted for the effects of all dilutive potential equity shares. Potential equity shares are deemed to be dilutive only if their conversion to equity shares would decrease the net profit per share from continuing ordinary operations. Potential equity shares are deemed to be converted as at the beginning of the period, unless they have been issued at a later date. Dilutive potential equity shares are determined independently for each period presented.

Impairment of assets (m)

The carrying amounts of assets are reviewed at each balance sheet date if there is any indication of impairment based on internal/external factors. An impairment loss is recognized wherever The carrying amounts of assets are reviewed at each plantic street out in model in the prester of the asset's net selling price and value in use. In assetsing value in use, the estimated future cash flows are discounted at the pre tax discount rate reflecting current market assessment of time value of money and risks specific to asset.

r impairment, depreciation is provided on the revised carrying amount of the asset over its remaining useful life.

A previously recognised impairment loss is increased or reversed depending on changes in circumstances. However the carrying value after reversal is not increased beyond the carrying value that would have prevailed by charging usual depreciation if there was no impairment.

Foreign currency transactions (n) (i) Initial Recognition

Foreign currency transactions are recorded in the reporting currency, by applying to the foreign currency amount the exchange rate between the reporting currency and the foreign currency at the date of the transaction.

(ii) Conversion

Foreign currency monetary items are reported using the closing rate. Non-monetary items which are carried in terms of historical cost denominated in a foreign currency are reported using the exchange rate at the date of the transaction.

(iii) Exchange Differences

Exchange differences arising on the settlement of monetary items or on reporting Company's monetary items at rates different from those at which they were initially recorded during the year, or reported in previous financial statements, are recognised as income or as expenses in the year in which they arise.

Expenses on issue of securities (0)

Expenses incurred with respect to issuance of securities are debited to securities premium account in accordance with the provisions of Section 52 of the Companies Act, 2013.

(p) Borrowing costs

Borrowing costs consists of interest and other ancillary cost that an entity incurs in connection with borrowing of funds. Ancillary costs incurred in connection such borrowings are amortised on a straight line basis over the tenure of such borrowings.

Employee share based payments (q)

In case of stock option plan, measurement and disclosure of the employee share-based payment plans is done in accordance with the Guidance Note on Accounting for Employee Share-based Payments issued by the Institute of Chartered Accountants of India. The Company measures compensation cost relating to employee stock option using the fair value method. Compensation expense is amortised over the vesting period of the option on a straight line basis.

(i) Provisioning norms for loans under financing activity (r)

Contingent provision for standard assets and provision for non-performing assets is determined based on management estimates subject to minimum requirements stipulated in the NHB Directions.

(ii) Write off (Loans under financing activity)

Loans are written off by the Company based upon management's assessment of ultimate recovery (net of recoveries, if any made during the year).

(5) Provisions

A provision is recognised when the Company has a present obligation as a result of past event; it is probable that outflow of resources will be required to settle the obligation, in respect of which a reliable estimate can be made. Provisions are not discounted to its present value and are determined based on best estimate required to settle the obligation at the balance sheet date. These are reviewed at each balance sheet date and adjusted to reflect the current best estimates.

Contingent liabilities (t)

A contingent liability is a possible obligation that arises from past events whose existence will be confirmed by the occurrence or non-occurrence of one or more uncertain future events beyond the control of the Company or a present obligation that is not recognized because it is not probable that an outflow of resources will be required to settle the obligation. A contingent liability also arises in extremely rare cases where there is a liability that cannot be recognized because it cannot be measured reliably. The Company does not recognize a contingent liability but discloses its existence in the financial statements.

Cash and Cash Equivalents (u)

Cash and Cash Equivalents for the purpose of cash flow statement comprise cash in hand and cash at bank including fixed deposit with original maturity period of three months and short term highly liquid investments with an original maturity of three months or less.
